I am conducting research on readers and producers of manga (Japanese comics). I have a grant from the British Academy to study the manga texts themselves. This ethics application is to extend this research to the readers and producers. I am requesting ethical approval to research a number of different sources of material. (1) material which is already publically available, e.g., internet posts, blogs, fan-sites and through twitter (only spontaneous twitter tweets will be used as data, i.e., the researcher will not become involved or contribute to twitter interaction for the purposes of data collection); (2) my observations and experiences of fan events such as manga and anime conventions; (3) interviews with readers and producers which could include face-to-face, skype, telephone, e-mail interviews. Data will be in the form of text, including transcripts of interviews, and I will use a variety of qualitative methods of analysis. Participants are likely to be young adults but some individuals will be older. Where I am involved in generating data through personal contact,

participants will be at least 16 years old. Although the topic of investigation could range over many types of manga and related material my central genre of interest is 'YAOI' or 'Boys' Love' (BL). This is a well known sub-genre of manga that has a relatively large, young female fan base. It is an erotic genre and so potentially a sensitive and delicate topic of investigation. I will contact potential participants through notices in appropriate places such as shops that sell manga, create a face-book page and information page linked to my academic website, by word of mouth, through direct e-mail and twitter contact, through fan-sites and online information sources, and through conferences and conventions. I will also contact university societies and other groups to advertise my research and recruit participants.

A.10 What are the main ethical issues with the research and how will these be addressed? 19

The central material I am researching is an erotic genre of manga and the participants (readers and producers of this material) will be largely young adult females. (1) When I generate material for analysis through personal contact I will ask participants to confirm that they are at least 16 years of age. (2) I will warn potential participants that I may ask them questions linked to the sexual content of manga, their interest in and response to this material, and clarify that they are under no obligation to provide answers to this line of questioning. (3) It is the norm for fans of manga to use a pseudonym when communicating about their interests and for mangaka (author-artists) to use pen-names. Moreover, given the erotic nature of this manga, some may feel embarrassed about their interest in it. Therefore it seems appropriate to request that, instead of always obtaining signed informed consent from participants, that I give the option of recording consent at the beginning of interviews completely anonymously. So, for example, if it is an audio-recorded interview I request ethical approval to state each consent question (see consent sheet) and take a verbal consent from the participant before commencing the interview; if it is a Skype or e-mail interview I request a similar format of recording consent via that mode of data collection rather than attempt always to obtain a signature. Offering these alternative modes of recording consent (1) actually offered better protection of the participant's anonymity in circumstances in which this may be of crucial importance to the participant, (2) may often be the only practical solution to recording consent when I am not meeting the participant faceto-face and (3) is less intrusive and invasive than requesting a signature. Each participant will be given an information sheet and a copy of the consent questions to keep, or if I am unable to transfer a copy personally or electronically, will be made available on the internet (for example, through the researcher's academic webpage) for external access, scrutiny, and download by potential participants.

Part C: The Research

C.1 What are the aims of the study? ²² (Must be in language comprehensible to a lay person.)

The aim of the research is to understand manga (Japanese comics) readers and producers from a UK perspective. In particular, I am interested in the readers and producers of the erotic sub-genre known as YAOI or Boys' Love (BL). Japanese products have a huge impact on youth sub-cultures world-wide and as yet there have been no studies on the fan base of YAOI/BL in the UK.

C.2 Describe the design of the research. Qualitative methods as well as quantitative methods should be included. (Must be in language comprehensible to a lay person.)

It is important that the study can provide information about the aims that it intends to address. If a study cannot answer the questions / add to the knowledge base that it intends to, due to the way that it is designed, then wasting participants' time could be an ethical issue.

I will analyse material from a number of different sources: (1) publically available material from the internet and from twitter (only spontaneous twitter tweets will be used as data, i.e., the researcher will not become involved or contribute to twitter interaction for the purposes of data collection); (2) my observations from attending relevant events, such as manga and anime conventions; (3) individual and group interviews conducted face-to-face, by skype, through email and on the telephone. I will recruit through attending relevant events, through making my research interests known at relevant outlets and through creating a face book page about the research, and contacting relevant individuals though their publically available contact details where relevant. Data will be in the form of text, including interview transcripts. I will use a variety of qualitative methods to analysis this material including forms of thematic and theoretically informed textual analysis.

C.3 What will participants be asked to do in the study? ²³ (e.g. number of visits, time, travel required, interviews etc)

In the aspects of the research in which I recruit participants, I will request an interview. The format of the interview will be convenient to the participant and could be through skype, by email, telephone, or face-to-face. If the interview is verbal, I will obtain consent to audio-record the interview. If relevant, and if the participant consents, there may be longitudinal element to the research and several interviews may be conducted with a participant over a period of time. However, in the main, I would anticipant participants contributing only one interview. If participants are willing to take part in follow-up data collection this will involve the clarification of existing topics of conversation and not new lines of questioning. If I wish to pursue a new line of investigation I will submit a new ethics application. The length of the interview is open to negotiation. Some may be very short – a matter of minutes. Others may be longer than an hour. Most interviews will be conducted one-to-one, but some participants may be interviewed in small groups. I anticipate that, if any travel is required, I will travel to the relevant venue as the researcher, most of which will be public fan events or meetings.

I will not agree to a venue that I do not feel comfortable with – for example a private home when I do not already know the interviewee. Mutually agreed venues could include a private room or quiet place in a public building.

Participants will be identified as manga/YAOI/BL readers and/or producers by their attendance at relevant meetings, relevant internet posts, publically available website information and twitter tweets, and by their making contact with the researcher who is known to be researching this topic.

I will approach participants at manga events and meetings, put up notices in relevant outlets (such as shops selling manga), contact individuals through publically available on-line sources (such as fan sites and twitter tweets), and make my interests and professional centact details

(such as fan-sites and twitter tweets), and make my interests and professional contact details known on-line (for example through a research-oriented face book page).

(iii) recruited? 26

If a potential participant confirms to the researcher that he/she is at least 16 years old, he/she will be given an information sheet and copy of the terms of consent – or, if more convenient, given the website at which this material can be found. If appropriate, the researcher will also give a verbal explanation of the research. Every potential participant will be given the chance to ask questions about the research and will have their questions answered. The research will only go ahead if the participant at least 16 years old and provides a record (written or audiorecorded) of their acceptance of the conditions of consent (see consent sheet). Special age restrictions apply to 'on-the-spot' data collection (see next section).

C.8 Will you be excluding any groups of people, and if so what is the rationale for that? ²⁷

Excluding certain groups of people, intentionally or unintentionally may be unethical in some circumstances. It may be wholly appropriate to exclude groups of people in other cases.

I will exclude from active data generation (such as interviews) participants under the age of 16 years since the material I am researching has sexual content and it does not seem viable to seek parental consent for participation or appropriate to be undertaking this particular study with individuals under 16 years old. It may be impossible for me to know the age of the individual generating relevant textual material on the internet or twitter so I will use my judgement to consider the appropriateness of including material for study obtained through such routes vis-à-vis the most likely age of the source. I will also exclude any individual 16 years or over who appear to be unable to give consent, for example, who is momentarily distressed or otherwise vulnerable or who appears to be under the influence of alcohol or drugs. I will follow the Mental Capacity Act rules for participants who fall under its remit. When I am requesting 'on-the-spot' consent for an interview and immediate, or very soon after, data collection, I will do so only with participants who are at least 18 years old. The standard setting for this research will be specific meetings for comics, manga, and anime fans such as fan conventions open only to individuals who have shown valid ID confirming that they are at least 18 years old. I will do my utmost to ensure that any individual from whom I collect data through 'on-the-spot' consent and interview is at least 18 years old and, if at all in doubt, will not undertake an interview.

C.9 How many participants will be recruited and how was the number decided upon? ²⁸

It is important to ensure that enough participants are recruited to be able to answer the aims of the research.

In principle, a single interview could generate sufficient material for a publishable in-depth case study. However, I intend to conduct several interviews. The total number depends on how easy it is to recruit and the resources I have to attend relevant events and to have interviews transcribed.

My aim in the first stage of this research is to attend AMECON at the University of Keele in August 2012. This will not involve recruitment posters/e-mails. Subsequent recruitment drives may do so but these materials will have to be designed knowing the specific outlet at which they will be displayed and have not therefore been appended to this application. I request that this ethics application is considered as it stands and that I will submit additional materials designed for specific outlets and modes of recruitment as an ethics amendment as and when I reach these stages of research.

I might take photographs at events. Where the event has a photograph-taking policy I will observe that policy. If I would like to have the option of using photographs to illustrate reports of the research I will discuss this with the people in the photographs and obtain their written consent for this use. Adrian Slater (University of Leeds solicitor) has given me a consent form for this purpose and has confirmed the suitability of the form I have amended for this research. I have appended this consent form to this application. Where I need to obtain this consent and receive it, I will ask individuals who are in the photo to sign two copies of the consent form – one for me and one to be kept by them.

Where data consists of publically available material, such as on-line posts or tweets, individuals will not be aware that their material is being used for research and will therefore not be able to withdraw from the research. In this case, every effort will be made to anonymise the material and to make it untraceable to its source. Tweets are not publically archived for more than a few days. However, with tweets and internet material I will attempt to avoid direct quotes and to modifying quotes in a small way that means that a search engine cannot be used to trace them. I will not name source websites or give identifying information about tweet sources. (All of this will be explained in publications stemming from this material). Where the researcher has personal contact with participants, they will be free to withdraw from the study at any time but warned that this may be impossible if material has already been accepted for publication. All material will be anonymised before analysis is conducted on it. I will remind participants at the end of the interview of their right to withdraw data at any time up to publication.

C.13 How long will the participant have to decide whether to take part in the research? ³¹
It may be appropriate to recruit participants on the spot for low risk research; however consideration is usually necessary for riskier projects.

Where possible, interview participants will be given at least 24 hours after receiving the information sheet, or website details containing this information, before deciding whether or not to take part in this research. However, I request permission to recruit participants on the spot and to conduct interviews, with consent, there and then when I am attending relevant events for the purposes of research. Potential participants will be attending these events, such as manga and anime conventions, because of their interest in relevant material, their willingness to make their interest public, and implicitly their willingness to talk about their interests – although, of course, I will not take for granted their willingness to talk to a

researcher. I seek ethical approval to use my judgement as an experienced researcher to approach individuals at relevant events to inquire about their potential willingness to take part in an interview about their interest in manga, particularly YAOI/BL, and, if they seem potentially willing, to talk through the information sheet and conditions of consent. If they agree to an interview, I will then given them the option of audio-recording consent and undertaking the interview straight away or at an agreed time later. Every participant taking part in such an interview will be given a hard copy of the information sheet and conditions of consent to take away with them. If they later change their mind about releasing the material for research purposes they will be able to contact me (by e-mail) to do so.

The topic forming the basis of the interview is the interviewee's interest in, and/or production of, manga and, in particular, a genre of erotic manga. This may be an embarrassing subject and may involve the participant discussing intimate and personal aspects of their lives. This will be made clear in the information sheet and, where possible, verbally prior to participants consenting to interview. It will also be made clear that the participant is under no obligation to answer any particular line of questioning and is free to leave the interview at any time without giving a reason. In essence, the context of the research will facilitate participation only when this feels comfortable for the participant and when the interview is underway – whether individual or group interview – every participant will have personal control over the level of disclosure with which they are happy. There will also be plenty of time to withdraw an individual contribution if, on reflection, the participant feels uncomfortable with their material being used for research purposes.

Participants will be warned in the information sheet, and verbally where possible, that the researcher may be obliged to alert relevant authorities should the participant reveal involvement in any serious criminal activity, intention to harm themselves or others, or if the researcher has good reason to suspect that the participant, themselves, is at serious risk of harm from others. If this is the case, the researcher may tell the participant that she intends to seek advice and will, at the earliest opportunity contact a relevant person such as the chair of the ethics committee. Most interviews will take place in public spaces or neutral locations such as a private room in a public building by appointment. The researcher will not agree to a location that she does not feel comfortable with. Interviews may take place in participants' homes but the researcher will only agree to this is she is already familiar with the participant and is comfortable with them. She will try and visit in daylight hours and will always let a responsible other person know where she has gone and when she is due back and telephone to let this person know that she is on her way home. Hello! I am an academic at the University of Leeds conducting research into manga, manga readers, and manga producers. In particular, I am interested in **Boys' Love/YAOI/shōnen-ai**. I received a grant from the British Academy to study the manga themselves and would like to extend this research by talking to manga readers and producers. This information sheet explains why the research is being carried out and what it involves.

What is the purpose of this study?

The purpose of this research is to further understanding of readers and producers of manga, particularly YAOI, from an anglophone perspective. Commercially translated original Japanese manga is increasingly popular across the world but there is little or no research about the English-speaking readers and producers.

Why have I been invited to take part?

If you are at least 16 years old, fluent (enough) in English, and a reader and/or producer of manga, particularly of YAOI, I would like to invite you to take part in this research because you will be able to tell me about your manga-related interests and activities. If I am asking you to do an interview almost immediately after approaching you about this research in person (e.g., at a convention), I need to be sure that you are at least 18 years old.

Do I have to take part?

No – it is entirely up to you whether or not you take part. If you are interested in taking part in the study, I will go through this information sheet with you to make sure that you fully understand what is involved, including the conditions of consent. You can ask me any questions you want about the study before you decide. If you would like to take part, you can decide if you would like to sign a consent form or just record your consent at the beginning without having to give a signature (e.g., verbally at the beginning of an audio-recorded interview). Giving consent does not mean that you have to do anything that you do not want to do. You can end the interview at any time, do not have to answer anything that I ask, and can contact me to take your interview out of the research at any time up to publication without having to give a reason. It may be difficult for me to remove your contribution from a report that has been accepted for publication so, if you do change your mind about contributing to this research, please try to let me know sooner rather than later – thanks!

What does the study involve?

The study involves taking part in a recorded discussion – a research interview with me about your manga-related interest and activities, particularly YAOI. I have a list of questions but I am happy for you to tell me about your experiences and opinions in your own way. The interview may be an audio-recorded face-to-face interview, but some interviews may be done by Skype, telephone, or through e-mails. Interviews may be one-to-one or may be conducted in a group. The interview may be very short or may last an hour or more depending on how much time you have and where it is conducted. Usually our contact will be just the one interview, but if you would like to contribute further I am happy to discuss this with you. I anticipate asking about how you got interested in manga and how you pursue this interest, to tell me about your favourite YAOI mangakas

and favourite YAOI publications, and your thoughts about the content of YAOI (including its sexual content), and your opinion about how YAOI is received in the Anglophone West.

Where will the research be done?

If our discussion is conducted on-line, on the telephone, or by e-mail there is a lot of flexibility when this can be done and we will come to an agreement about this together. If the interview is face-to-face, this may have been pre-arranged e.g., if it is a group interview with a university society. On the other hand, I may have approached you personally at an event and we may just do an interview straight away or agree to meet somewhere later to conduct the interview. In this case, because I am not giving you a lot of time to think about taking part, I need to be sure that you are at least 18 years old. For privacy and for a clear audio-recording, it is helpful if we do the interview somewhere that is reasonably quiet but, given that we probably won't know each other very well, it is probably also appropriate that the location is a public one. We will agree a time and location together.

What about confidentiality?

Audio-recording of the interviews will be kept on a private and secure university computer, locked with a username and password. Audio-recordings will be typed up into a transcript. This may be done by a person other than the researcher. If this is the case, the transcriber will keep the content of the interview confidential and will not hold onto any of the material after completing the transcription. Effort will be made so that you will not be identifiable in the transcripts or other material, such as e-mails, used for analysis. For example, potentially identifying details will be omitted and pseudonyms (false names) will be used. I will ask your consent to use quotes from our recorded discussions in reports of the research but you should not be identifiable from these quotes. If you chose to sign a consent form, I will keep this in safe and confidential storage. If I share data for analysis with other researchers, they will only have access to the anonymised version of our discussions and, if required, know only very general information about you (e.g., approximate age, mode of recruitment, etc.).

There are some limits to confidentiality in all research activity. I may be obliged to alert relevant authorities if a participant reveals involvement in any serious criminal activity, intention to harm themselves or others, or if I have good reason to suspect that the participant is at serious risk of harm from others. If this is the case, I may tell you that I intend to seek advice and will, at the earliest opportunity contact a relevant person such as the Chair of my School Ethics Committee. However, I can reassure you that my research does not actively seek such information and, if I think you may be about to disclose something along these lines during the interview, I will remind you of my obligations.

Are there any risks in taking part?

I do not expect there to be any significant risks in taking part. However, some topics related to this research may be sensitive. For example, some manga, including YAOI, have erotic themes and some manga on the internet may contravene international/UK copyright and sexual content/obscenity laws. I would like to ask your opinion on these kinds of topics but you can decline this line of questioning without having to give a reason and I will, of course, respect your wishes.

Are there any benefits in taking part?

Although it is not the primary purpose of the research, taking part may be interesting and it might be good to know that you are promoting the understanding of a phenomenon that has the potential to be misrepresented or misunderstood in mainstream culture.

Ethics

The ethical guidelines for this research have been set out by the British Psychological Society code of ethics. These guidelines include ethical principles such as making sure you know what will happen and are happy to take part, explaining that you can stop the interview at any time, and protecting your identity.
